### EARLY YEARS FUNDING (KINDERGARTEN & RECEPTIONS FEES)

All 3 to 4-year-olds are eligible for Early Years Funding (15 hours a week) and there is no need to apply for a code. Working parents may also be eligible for the extended 15 hours a week (totalling 30 hours) for 3 and 4-year-old children however, this will need to be applied for. Early Years Funding can be used on School fees up until (and inclusive of) the term in which they turn 5 years old. For example, if your child turns 5 in June (during the Summer term), Early Years Funding can be used for the Autumn, Spring and Summer terms for Reception.

*Agreed Additional Services Charge: At Berkhampstead School we take pride in offering exceptional education and care for the Early Years Foundation Stage however, the local authority funding rate set by DfE is only intended to cover the minimum requirements of the EYFS. This therefore requires funding beyond that offered by the Early Years Funding to ensure we can deliver this exceptional education as evidenced in our most recent ISI inspection report. The optional agreed additional services charge covers the following additional items: Meals/snacks (25%), Consumables (30%), Additional activities (e.g. subject-specialist teaching) (45%). This provision therefore requires funding beyond that offered by the Early Years Funding to ensure we can deliver this exceptional service and care.*
