



BERKHAMPSTEAD SCHOOL AND DAY NURSERIES

Acceptable Use Policy

Scope of this Policy

This policy applies to all members of the School and Day Nurseries community (staff or pupils) who use School and Day Nurseries IT systems, as a condition of access. Access to School and Day Nurseries systems are not intended to confer any status of employment on any contractors.

Online behaviour

As a member of the School and Day Nurseries community you should follow these principles in all of your online activities:

- The School and Day Nurseries cannot guarantee the confidentiality of content created, shared and exchanged via School and Day Nurseries systems. Ensure that your online communications, and any content you share online, are respectful of others and composed in a way you would wish to stand by.
- Do not access, create or share content that is illegal, deceptive, or likely to offend other members of the School and Day Nurseries community (for example, content that is obscene, or promotes violence, discrimination, or extremism, or raises safeguarding issues).
- Respect the privacy of others. Do not share photos, videos, contact details, or other information about members of the School and Day Nurseries community, even if the content is not shared publicly, without going through official channels and obtaining permission.
- Do not access or share material that infringes copyright, and do not claim the work of others as your own.
- Do not use the internet to distribute malicious software, to damage, interfere with, or gain unauthorised access to the computer systems of others, or carry out illegal activities.
- Staff should not use their personal email, or social media accounts to contact pupils or parents, and pupils and parents should not attempt to discover or contact the personal email addresses or social media accounts of staff.

Using the School and Day Nurseries's IT systems

Whenever you use the School and Day Nurseries' IT systems (including by connecting your own device to the network) you should follow these principles:

- Only access School and Day Nurseries IT systems using your own username and password. Do not share your username or password with anyone else.
- Do not attempt to circumvent the content filters or other security measures installed on the School and Day Nurseries IT systems, and do not attempt to access parts of the system that you do not have permission to access.

- Do not attempt to install software on, or otherwise alter, School and Day Nurseries IT systems.
- Do not use the School and Day Nurseries IT systems in a way that breaches the principles of online behaviour set out above.
- Remember that the School and Day Nurseries monitors use of the School and Day Nurseries IT systems, and that the School and Day Nurseries can view content accessed or sent via its systems.

The School and Day Nurseries' network is actively monitored by Securus, a safeguarding monitoring platform which flags potentially concerning or inappropriate digital activity to designated safeguarding leads. In addition, all internet traffic is filtered by our service provider EXA Networks to block access to illegal or harmful online material in accordance with *KCSIE 2025* and *UK Government filtering standards*.

Passwords

Passwords protect the School and Day Nurseries' network and computer system and are your responsibility. They should not be obvious (for example "password", 123456, a family name or birthdays), and nor should they be the same as your widely-used personal passwords. You should not let anyone else know your password, nor keep a list of passwords where they may be accessed, and must change it immediately if it appears to be compromised. You should not attempt to gain unauthorised access to anyone else's computer or to confidential information to which you do not have access rights.

Use of Property

Any property belonging to the School and Day Nurseries should be treated with respect and care and used only in accordance with any training and policies provided. You must report any faults or breakages without delay to the Bursar.

Use of School and Day Nurseries systems

The provision of School and Day Nurseries email accounts, Wi-Fi and internet access is for official School and Day Nurseries business, administration and education. Staff and pupils should keep their personal, family and social lives separate from their School and Day Nurseries IT use and limit as far as possible any personal use of these accounts. To use the School/Day Nurseries Wi-Fi staff must install a certificate onto their device which allows for monitoring by the Designated Safeguarding Lead or Bursar. Again, please be aware of the School and Day Nurseries' right to monitor and access web history and email use.

Use of personal devices or accounts and working remotely

All official School and Day Nurseries business must be conducted on School and Day Nurseries systems, and it is not permissible to use personal email accounts for School and Day Nurseries business. Any use of personal devices for School and Day Nurseries purposes, and any removal of personal data or confidential information from School and Day Nurseries systems – by any means including email, printing, file transfer, cloud or (encrypted) memory stick – must be registered and approved by the Bursar.

Where permission is given for use of personal devices, these must be subject to appropriate safeguards in line with the School and Day Nurseries' policies, including multi-factor authentication, VPN and encryption etc.

Monitoring and access

Staff, parents and pupils should be aware that School and Day Nurseries email and internet usage (including through School and Day Nurseries Wi-Fi) will be monitored for safeguarding,

conduct and performance purposes, and both web history and School and Day Nurseries email accounts may be accessed by the School and Day Nurseries where necessary for a lawful purpose – including serious conduct or welfare concerns, extremism and the protection of others.

Monitoring and filtering systems, including Securus and EXA Networks, are in place to support online safety and compliance with statutory safeguarding duties. These systems provide alerts where potential risks are identified and help ensure that inappropriate material is filtered effectively.

Any personal devices used by pupils, whether or not such devices are permitted, may be confiscated and examined under such circumstances. The School and Day Nurseries may require staff to conduct searches of their personal accounts or devices if they were used for School and Day Nurseries business in contravention of this policy, and in particular if there is any reason to suspect illegal activity or any risk to the wellbeing of any person.

Compliance with related School and Day Nurseries policies

To the extent they are applicable to you, you will ensure that you comply with the School and Day Nurseries' e-Safety Policy, Anti-Bullying Policy, Staff Data Protection Policy, Safeguarding policy and KCSIE 2025 regarding online safety. This includes adherence to the School and Day Nurseries' network monitoring and filtering standards operated through Securus and EXA Networks.

Retention of digital data

Staff and pupils must be aware that all emails sent or received on School and Day Nurseries systems will be routinely deleted after 1 year and email accounts will generally be closed and the contents deleted within 1 year of that person leaving the School and Day Nurseries.

Any information from email folders that is necessary for the School and Day Nurseries to keep for longer, including personal information (e.g. for a reason set out in the School and Day Nurseries privacy notice), should be held on the relevant personnel or pupil file. Important records should not be kept in personal email folders, archives or inboxes, nor in local files. Hence it is the responsibility of each account user to ensure that information is retained in the right place or, where applicable, provided to the right colleague. That way no important information should ever be lost as a result of the School and Day Nurseries' email deletion protocol.

If you consider that reasons exist for the protocol not to apply or need assistance in how to retain and appropriately archive data, please contact the Bursar.

Breach reporting

The law requires the School and Day Nurseries to notify personal data breaches, if they are likely to cause harm, to the authorities and, in some cases, to those affected. A personal data breach is a breach of security leading to the accidental or unlawful destruction, loss, alteration, unauthorised disclosure of, or access to, personal data.

This will include almost any loss of, or compromise to, personal data held by the School and Day Nurseries regardless of whether the personal data falls into a third party's hands. This would include:

- loss of an unencrypted laptop, USB stick or a physical file containing personal data;
- any external hacking of the School and Day Nurseries' systems, eg through the use of malware;
- application of the wrong privacy settings to online systems;
- misdirected post, fax or email;
- failing to bcc recipients of a mass email; and
- unsecure disposal.

The School and Day Nurseries must generally report personal data breaches to the ICO without undue delay (ie within 72 hours), and certainly if it presents a risk to individuals. In addition, controllers must notify individuals affected if that risk is high. In any event, the School and Day Nurseries must keep a record of any personal data breaches, regardless of whether we need to notify the ICO.

If either staff or pupils become aware of a suspected breach, they should contact the Bursar. Data breaches will happen to all organisations, but the School and Day Nurseries must take steps to ensure they are as rare and limited as possible and that, when they do happen, the worst effects are contained and mitigated. This requires the involvement and support of all staff and pupils. The School and Day Nurseries' primary interest and responsibility is in protecting potential victims and having visibility of how effective its policies and training are. Accordingly, falling victim to a data breach, either by human error or malicious attack, will not always be the result of a serious conduct issue or breach of policy; but failure to report a breach will be a disciplinary offence.

Breaches of this policy

A deliberate breach of this policy by staff or pupils will be dealt with as a disciplinary matter using the School and Day Nurseries' usual applicable procedures. In addition, a deliberate breach by any person may result in the School and Day Nurseries restricting that person's access to School and Day Nurseries IT systems.

If you become aware of a breach of this policy or the e-Safety Policy, or you are concerned that a member of the School and Day Nurseries community is being harassed or harmed online you should report it to the Bursar. Reports will be treated in confidence wherever possible.
