



# BERKHAMPSTEAD SCHOOL AND DAY NURSERY

## **Complaints Procedure Berkhampstead School and Day Nursery**

### **Introduction**

Berkhampstead has long prided itself on the quality of the teaching and pastoral care provided to its children. However, if parents do have a complaint, they can expect it to be treated by the School and Day Nursery with care and in accordance with this procedure. Berkhampstead makes its complaints procedure available to all parents of pupils and of prospective pupils on the website and in the School and Day Nursery Office.

In accordance with paragraph 32(1)(b) of Schedule 1 to the Education (Independent School Standards) Regulations 2014, Berkhampstead will make available to parents of pupils and of prospective children and provide, on request, to the Chief Inspector, the Secretary of State or an independent inspectorate, details of the complaints procedure and the number of complaints registered under the formal procedure during the preceding nursery year.

### **What Constitutes a Complaint?**

A complaint is an expression of dissatisfaction with a real or perceived problem. It may be made about the organisation as a whole, about a specific department or about an individual member of staff, and any matter about which a parent is unhappy and seeks action is within the scope of this procedure. A complaint is likely to arise if a parent believes that the School or Day Nursery has done something wrong, failed to do something that it should have done or has acted unfairly. Parents can be assured that all concerns and complaints will be treated seriously and confidentially. We are here for your child and you can be assured that your child will not be penalised for a complaint that you or your child raises in good faith.

## The three-stage Complaints Procedure:

### Stage 1 - Informal Resolution

- We hope that most complaints will be resolved quickly and informally. Early communication of concerns is often the key to successful and painless resolution for all parties.
- If parents have a complaint they should normally contact their son/daughter's key-worker, class teacher or form teacher. In many cases, the matter will be resolved immediately by this means, to the parents' satisfaction.

If the member of staff concerned cannot resolve the matter alone, it may be necessary for him/her to consult a member of the management team.

- Staff will report all formal parental complaints to their line manager who will in turn inform the Day Nursery Manager and/or Head of School/Executive Head making a file note of the date of the complaint, nature of the complaint and what action was taken. A written record will be kept.
- Complaints made informally or directly to members of the management team will usually be referred to the relevant tutor, teacher, or key worker unless they deem it appropriate to deal with the matter personally.
- A complaint about the Executive Head, Head of School or Day Nursery Manager should be made to the Chair of Governors, Mr M Kirby, (via the Clerk to Governors) in the first instance who will attempt to resolve it directly with the parent.
- On receipt of a complaint, the member of staff concerned will make a **written record of all concerns and complaints and the date on which they were received**. Should the matter not be resolved within 5 working days or in the event that the member of staff concerned, or the member of senior management and the parent fail to reach a satisfactory resolution then **the parents will be advised to proceed with their complaint in accordance with stage 2** of this procedure.

### Stage 2 - Formal Resolution

- If the complaint cannot be resolved on an informal basis, then the parents should put their complaint in writing to the Day Nursery Manager and/or Head of School/Executive Head. They will decide, after considering the complaint, the appropriate course of action to take. In most cases, they will meet or speak to the parents concerned, normally within 5 working days of receiving the complaint, to discuss the matter. If possible, a resolution will be reached at this stage. During school holidays, contact from the Head of School or Executive Head within five days may not be possible but your complaint will be addressed within a maximum of 28 days.
- It may be necessary for the Day Nursery Manager and/or Head of School/Executive Head to investigate the matter further.

- The Day Nursery Manager and/or Head of School/Executive Head will keep written records of all meetings and interviews held in relation to the complaint. These will be kept on file for at least seven years.
- Once the Day Nursery Manager and/or Head of School/Executive Head is satisfied that, so far as is practicable, all of the relevant facts have been established, a decision will be made, and parents will be informed of this decision in writing. Reasons will be given for this decision.
- If parents remain dissatisfied, they should proceed to Stage 3 (below).

### **Under 5's Education – EYFS in the School and Day Nursery**

Complaints regarding Kindergarten Education and the Early Years Foundation Stage (any age up to Year 1) not resolved by stages one and two above may be made to OFSTED and/or ISI – the Independent Schools' Inspectorate.

Ofsted regulations require that complainants will be notified of the outcome of an investigation within 28 days of the school having received the complaint. We will try to resolve issues more quickly in accordance with the policy outlined above.

The School will provide Ofsted, on request, with a written record of all complaints made during any specified period and the action that was taken as a result of each complaint.

### **Stage 3 - Panel Hearing**

- Parents may contact the Chairman of the Governors, Mr M Kirby (via the Clerk to Governors), who has been appointed by the Governors to call hearings of the Complaints Panel.
- The Panel will consider the complaint. The Panel will consist of at least 3 persons not directly involved in the matters detailed in the complaint, one of whom shall be independent of the management and running of the school and day nursery. Each of the Panel members shall be appointed by the Governors. The Chair of Governors will acknowledge the complaint and schedule a hearing to take place as soon as practicable and normally **within 10 working days**.

- If the Panel deems it necessary, it may require that further particulars of the complaint or any related matter be supplied in advance of the hearing. Copies of such particulars shall be supplied to all parties not later than two working days prior to the hearing.
- The parents may be accompanied to the hearing by one other person. This may be a relative, teacher or friend. Legal representation is unlikely to be necessary but may be used.
- If possible, the Panel will resolve the parents' complaint immediately without the need for further investigation.
- Where further investigation is required, the Panel will decide how it should be carried out. They will consider the facts, reach a decision and may make recommendations, within five days of the Hearing.
- The Panel will write to the parents informing them of its decision and the reasons for it; the decision may be emailed if requested. The decision of the Panel will be final. The Panel's findings and, if any, recommendations will be sent in writing to the parents, and/or Head of School/Executive Head and/or Day Nursery Manager, the Governors and, where relevant, the person complained of. They will also be available for Inspection on the premises for the Governors, Head of School, Executive Head and Day Nursery Manager.
- The school will keep a written record of all Formal Complaints
  - (i) whether they are resolved following a formal procedure, or proceed to a panel hearing; and
  - (ii) action taken by the school as a result of these complaints (regardless of whether they are upheld);

Parents can be assured that all concerns and complaints will be treated seriously and confidentially. The correspondence, statements and records relating to individual complaints are kept confidential except where the Secretary of State or a body conducting an inspection under section 108 or 109 of the 2008 Act requests access to them.

In the previous year, there were no formal complaints.
