### Risk Assessments of trips, activities and areas

#### **Definition**

<u>Risk Assessment</u>: This is predominantly a Health and Safety term which refers to the process through which hazards are identified, and the risks they pose evaluated.

A risk assessment is a means of auditing the potential for unwanted situations to occur, enabling decisions to be made about steps which could minimise the possibility of the situation arising.

<u>Hazard</u>: A hazard is a source or a situation with the potential for harm in terms of human injury or ill health, damage to property, damage to the environment, or a combination of these. This could be:

- How people work and how plant and equipment are used.
- What chemicals and substances are used.
- What safe or unsafe practices exist.
- The general state of the premises/areas.

<u>Risk:</u> A risk is the chance of something happening that will have a negative effect. The level of risk reflects: the likelihood of the unwanted event and the potential consequences of the unwanted event.

The simplest way of assessing risk is to use a numerical system, in which calculations could be made, taking into account the precautions which are already in place and imagining the "worst case" scenario if nothing further is done. Once all these ratings have been recorded, the school can examine further measures which could be put into place to reduce the risk, if the risk rating appears to be too high. The key advantage of using a numerical approach to rate risk is that it is a simple way of working out which areas need most urgent attention. Once the hazard has been identified, Staff will assess the likelihood of harm occurring, with '1' being 'not likely' and 5 being 'extremely likely'. Staff will also apply a severity rating, with '1' being 'low' and '5' being 'high', for example serious injury or death. The staff member completing the risk assessment will comment on the controls in place, before reapplying the risk calculations following these controls. Any further remarks or control measures will then be added.

What needs to be risk assessed?

- 1. All classrooms, corridors, play areas, toilets and communal areas.
- 2. All regular activities carried out by the school swimming, sport outside school, playing fields, trips to the recreational ground or the church.
- 3. Any school trip or expedition outside agencies will also have a risk assessment.
- 4. Any one-off activity e.g. specialised science experiments.

#### **Completing Risk Assessments**

Multiplying the likelihood and severity of any risks together, will result in a risk rating. The issue at stake at all times when carrying out risk assessments is to ensure the safety and welfare of all those involved. Risk assessments are to be reviewed annually and completed for:

- i) <u>Trips:</u> A trip pack is to be completed by the lead teacher on the trip. The lead teacher will sign a complete a risk assessment for the trip, ensuring all members of staff on the trip sign to confirm they have read this before being reviewed by the Bursar. They will also attach a copy of the risk assessment from the venue where appropriate.
- ii) Areas, rooms and activities: Risk assessments for areas, rooms and activities are to be completed on an annual basis by the relevant member of staff responsible for that area and reviewed by the Bursar. See 'Appendix A' for staff responsibilities and areas, and 'Appendix B' for the location and references of each area.
- iii) <u>Children</u> (e.g. disabilities, severe injuries): Risk assessments for children are to be completed by the relevant member of staff responsible and reviewed by the Bursar.
- iv) Staff (e.g. pregnancy, severe injuries): Risk assessments for staff are to be completed by the employee's Line Manager and reviewed by the Bursar.

#### What extra measures need to be put in place?

Risk Assessment should not be an isolated process, but something which is ongoing across the whole school. Effective Risk Assessments always follow the five key stages outlined below (see 'Appendix C' for the risk assessment templates):

STEP ONE	Make a list of all hazard and outcome associated to the hazard with no controls in pace.
	These should include the various types of hazards as mentioned earlier including unsafe acts, physical conditions and omissions.
STEP TWO	For each hazard, decide who might be harmed and calculate the risk
	with before controls measures are in place.

STEP THREE	Evaluate the risk of each hazard and determine what controls are in place to mitigate the risk.
STEP FOUR	For each hazard, calculate the risk with after controls measures are in place. Review the risk of each hazard with the controls in and evaluate whether the residual risk is at a comfortable level.
STEP FIVE	Review your assessment during the activity/period and revise as necessary.

#### Leadership Responsibilities

All risk assessments are to be reviewed by the Bursar. The Bursar may seek guidance from the Headteacher, Director of Day Nurseries, Executive Headteacher or Health and Safety Governor if/where required.

Any activity with a hazard with a risk of 15, after controls have been applied, should not be attended unless approved by the Bursar and/or Health and Safety Governor.

The Bursar and/or Headteacher/Day Nursery Manager should be made aware of any activity with a hazard with a risk of 12 or over, after controls have been applied.

The overall aim of any risk assessment is to reduce the level of all residual risks to a level where all those concerned accept and tolerate them.


